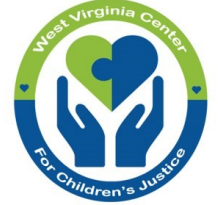




Trauma-Focused Cognitive Behavioral Therapy Training



Trauma-Focused Cognitive Behavioral Therapy (TF-CBT) is a research based intervention model developed by Cohen, Mannarino, and Deblinger for children aged 3-18 who are experiencing significant emotional and behavioral difficulties related to traumatic life events. TF-CBT has proven to be effective in improving PTSD symptoms, depression, anxiety, externalizing behaviors, feelings of shame, and mistrust. Therapists who attend this training will learn to identify appropriate cases for TF-CBT and will learn to deliver the treatment components in a way that is faithful to the model but allows for flexibility and creativity.

This training is available to WV therapists who are not currently TF-CBT certified, and:

1. Is currently or willing to providing mental health services on site at schools/Child Advocacy Centers
2. Has a Master's degree and is license eligible in psychology, counseling or social work.
3. Committed to participating with the Handle with Care Program

Program Requirements:

Over the course of a year, participants in this training must:

- Complete 10 hour TF-CBT webinar before the initial 2-day training- \$35 fee
- Attend initial TF-CBT Virtual Workshop \$75 fee
- Complete 9 follow-up supervisory consultation calls with the trainer: \$75 fee
